As a Prelude to this Presentation.....

How to Protect Yourself in the Workplace during a Pandemic

The best strategy to reduce the risk of becoming ill with pandemic influenza is to avoid crowded settings and other situations that increase the risk of exposure to someone who may be infected. If you must be in a crowded setting, minimize your time there. Some *basic* hygiene and social distancing precautions that can be used in every workplace include the following:

Stay home if you are sick.

Wash your hands frequently with soap and water for 20 seconds or with a hand sanitizer if soap and water are not available.

Avoid touching your nose, mouth and eyes.

Cover your coughs and sneezes with a tissue, or cough and sneeze into your upper sleeve. Dispose of tissues in no-touch trash receptacles.

Wash your hands or use a hand sanitizer after coughing, sneezing, or blowing your nose.

Avoid close contact (within 6 feet) with coworkers and customers.

Avoid shaking hands and always wash your hands after physical contact with others.

If wearing gloves, always wash your hands after removing them.

Keep frequently touched common surfaces (for example, telephones, computer equipment, etc.) clean.

Try not to use other workers' phones, desks, offices, or other work tools and equipment.

Minimize group meetings; use e-mails, phones and text messaging. If meetings are unavoidable, avoid close contact (within 6 feet) with others and ensure that the meeting room is properly ventilated.

Limit unnecessary visitors to the workplace.

Maintain a healthy lifestyle; attention to rest, diet, exercise and relaxation helps maintain physical and emotional health.

Low Country Membership Committee SOP

Goal: Membership Retention & Growth

- Membership Chair checks the Chapter Roster (In Members Only) for new or transferred members once per month. Only the Chapter President and Membership Chair have access to the Roster.
- New or Transferred members are Welcomed to the Chapter via email, sent a Low Country Chapter Informational Letter and Low Country Chapter Membership Directory
- Membership Chair dispenses Name Tags at the monthly meetings and welcomes members, especially new or transferred members
- The Newsletter Editor is notified of New Members immediately via email and sent updated email list at least quarterly
- Membership Directory is emailed to members quarterly. “Undeliverable” emails are checked to ensure updated information regarding members.
- Inconsistencies of contact information is verified with members via phone or email
- Membership Chair will recommend members update information with ASSE Headquarters or will update the information for the members
- Membership Chair contacts those members whose membership has lapsed and reminds them to contact ASSE Headquarters to renew membership
- Membership Chair notifies Low Country President of Membership Headcount for Quarterly ROC Meeting Chapter Report
- Executive members, members and etc. contact the Membership Chair with potential new members. The Membership Chair will follow up with a phone call, email and application for Membership.
